Legacy Liabilities Settled & Employee Bonuses

Highlights

engage:BDR (“EN1 or Company”) (ASX:EN1 and EN1O) is pleased to present shareholders with commentary for shares issued today to reduce trade credit liabilities and for employee bonuses.

Legacy Liabilities

Legacy liabilities have been on the Company’s balance sheet for many years before its IPO / listing on the ASX. Many of the liabilities are disputed invoices due to publisher ad fraud and violations of EN1’s advertising terms and conditions by publishers. The Company elected not to pay many of these invoices because these publishers signed EN1’s contracts and through the formal dispute process, the Company has demonstrated it typically prevails. In the interest of preserving time and achieving a stronger balance sheet position quicker, the Company’s attorneys have been working aggressively to settle and or dismiss the liabilities. About 20 accounts make up 85% of the aged balance; there are 331 total aged accounts.

Employee Bonuses

All EN1 employees have part of their compensation based on the individual's contribution to the Company's achievement and performance of goals. These bonuses are paid quarterly, typically in cash; many employees prefer to hold EN1 shares instead of cash, and as a result, the Company has been able to conserve its cash by paying these bonuses in shares. For Q3, bonuses (Q2 paid on 9 August 2019), the Company is retaining A\$125K in cash. The average tenure of the EN1 employee currently is 8 years, with the majority of the team employed for 11 years, since inception (9 of 15 people).
